INSTRUCTIONS

1. ALL STALLIONS NOT REGISTERED WITH THE PtHA ARE REQUIRED TO BE **LISTED** BY THE PtHA TO ENABLE THEIR GET FOALED IN 1993 AND THEREAFTER TO BE ELIGIBLE FOR NORMAL PtHA REGISTRATION. The listing fee is \$25.00 for each approved outcross stallion. Contact the PtHA office for the appropriate and necessary listing application, which must be completed by the recorded owner of the stallion and be submitted with a current copy of the stallion's approved outcross registration certificate verifying his current ownership and pedigree for at least three consecutive generations.
2. EFFECTIVE 1/01/90, ALL APHA STALLIONS (COLORED OR BREEDING STOCK REGISTERED) OR ANY OTHER APPROVED OUTCROSS REGISTERED STALLIONS OTHERWISE ELIGIBLE FOR PtHA REGISTRATION (THROUGH THEIR COLOR MARKINGS OR BLOODLINES AND BACKGROUND) MUST BE **REGISTERED** WITH THE PtHA. (i.e. They cannot be LISTED with PtHA; they must be **REGISTERED**.)
3. Previous year Stallion Breeding Reports submitted with the initial stallion listing or registration application require the annual filing fee of \$10.00 per year submitted. After the stallion has been duly registered or listed (as applicable), late or previous year Stallion Breeding Reports submitted will be assessed a late fee of \$25.00 additional to basic filing fee.
4. PtHA registered stallions **do not also** need to be **LISTED** to allow for the registration of their get.
5. The PtHA office can only accept Stallion Breeding Reports for PtHA registered or listed stallions. If your stallion has not yet been PtHA registered or listed, please do not submit a Stallion Breeding Report prior to application for registration or listing of that stallion.
6. Maintain a separate record sheet on each stallion offered for public service.
7. The **RECORDED** owners or lessees of all registered or listed stallions, on or before the 31st day of December of each breeding year, shall submit to the PtHA business office a written report on forms furnished by the PtHA showing all mares bred to said stallion during that calendar year.
8. Be sure that the last recorded owner of the mare is the person who contracts the breeding to this stallion and is the same name as provided on reverse side of this form as recorded owner of mare at the time of breeding.
9. Insist on seeing the registration certificate of each mare bred, if applicable, to obtain accurate names and registry information.
10. Give exact date(s) bred. If more than one service is given a mare, be sure to provide the different dates.
11. If pasture bred, give date mare was turned into pasture with stallion and the date she was removed from pasture or stallion.
12. Keep a copy of this report for your files and future reference. The PtHA office will not divulge information submitted herein and cannot provide copies once a report is received or filed.
13. List all mares exposed, whether pronounced in foal or not.
14. Only one breeding season/calendar year is allowed per form/fee. Additional years must be submitted on separate forms and paid with separate fees.
